

## **RETURN CRITERIA**

#### New merchandise

New merchandise must be returned in new condition, and in its original packaging.

#### **Defective Product**

• Defective products are subject to manufacturer's warranty.

## The following items cannot be returned:

- Merchandise that has been modified, painted or installed.
- Discontinued items purchased beyond 12 months.
- Special Orders.
- Audio Products.
- Optima Batteries.



Returning Goods

The procedure for returning merchandise is explained as outlined below.


